

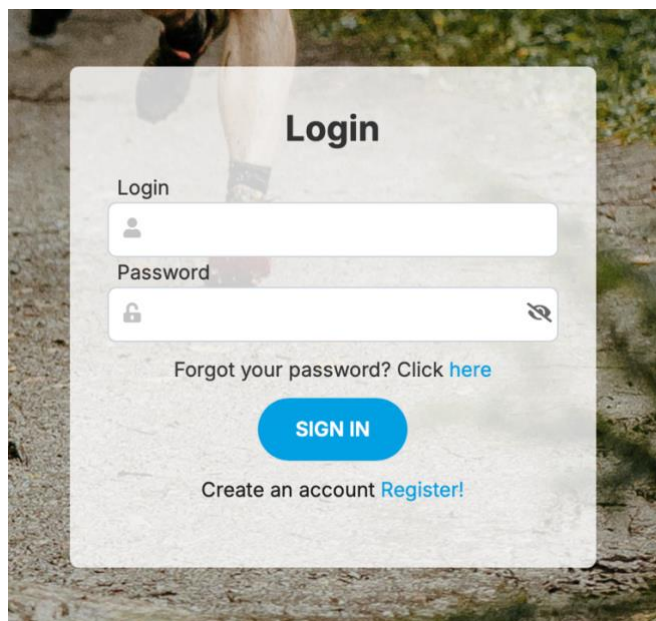

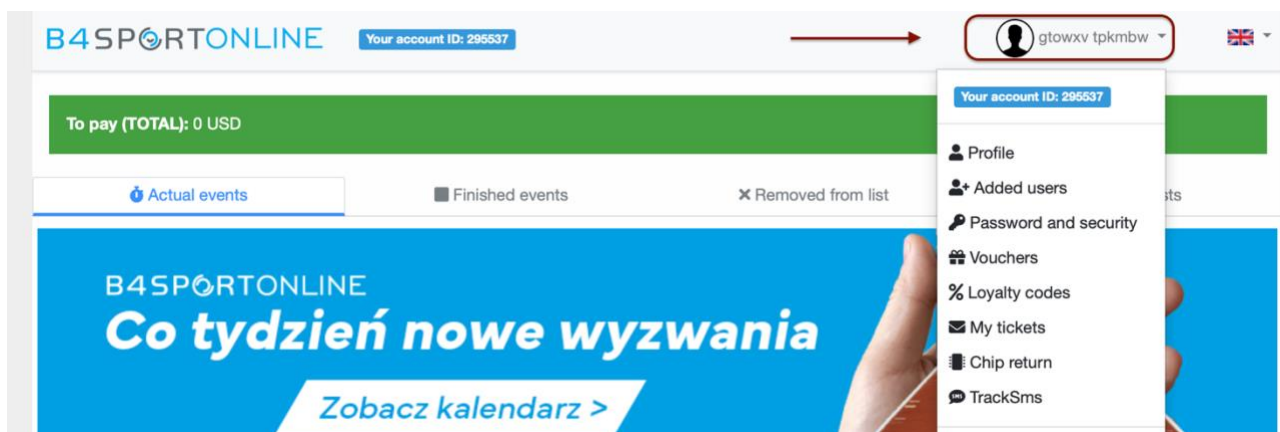
## I. B4SPORTONLINE.PL

1. Log in to the <https://b4sportonline.pl> platform using the same login and password you use on the platform or in the mobile app.

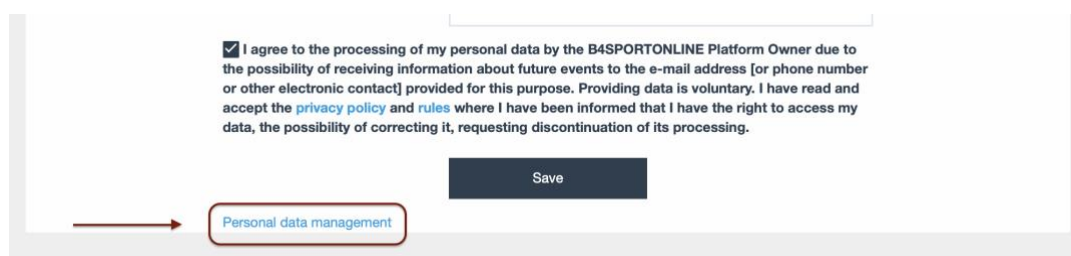


If you have forgotten your password, you can reset it by using the “Forgot your password” option.

2. After logging in, click your Name next to the avatar in the top-right corner of the page. This will expand the menu.



3. In the menu, select “Profile.” Once you enter your Profile page, scroll down and click the link “Personal data management.”



4. On the "Personal Data Management" page, re-enter your password and select "Show your data." You will be taken to a page displaying the personal data managed by B4SPORTONLINE and the associated mobile applications.

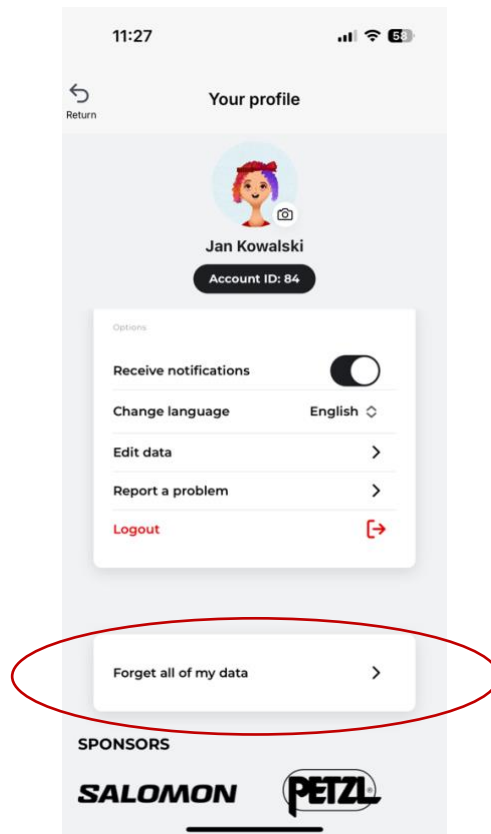
5. At the bottom of the "Personal data" page, click "Forget all my data" to start the account deletion process.



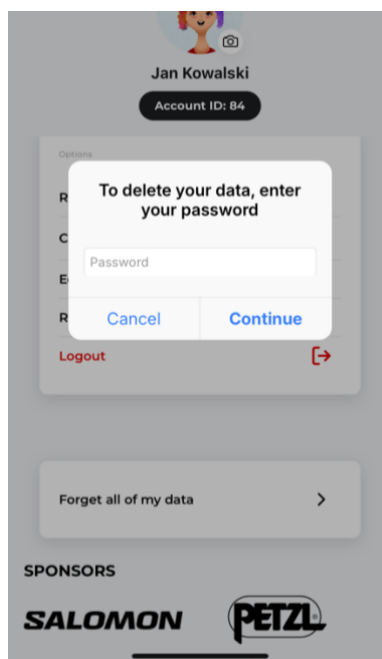
6. Confirm that you want to delete your data.
7. You will receive an email with a verification code at the email address associated with your account. Enter this code in your profile to complete the process.

## II. DFBG Mobile App

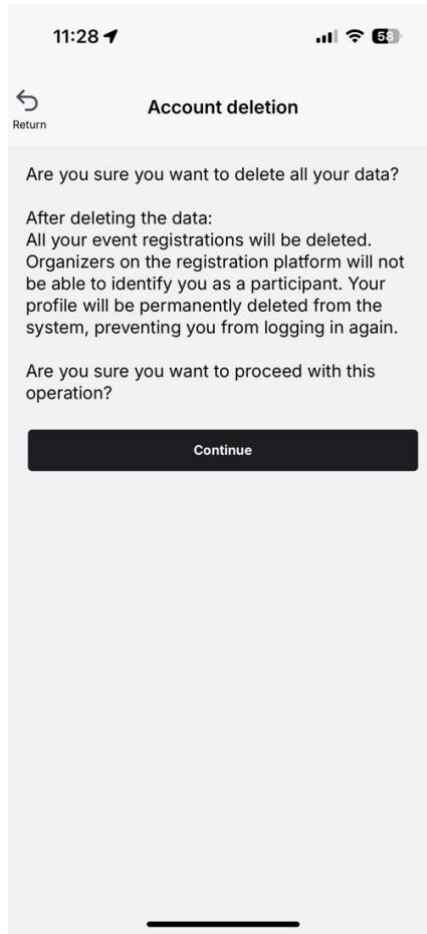
1. Log in to DFBG Mobile App using the same login and password you use on the platform <https://b4sportonline.pl>
2. After logging in, go to your profile and select the "Forget all my data" option



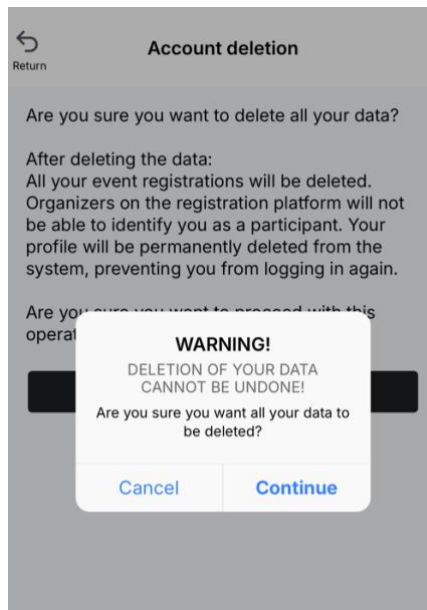
3. You will be prompted to re-enter your password for security



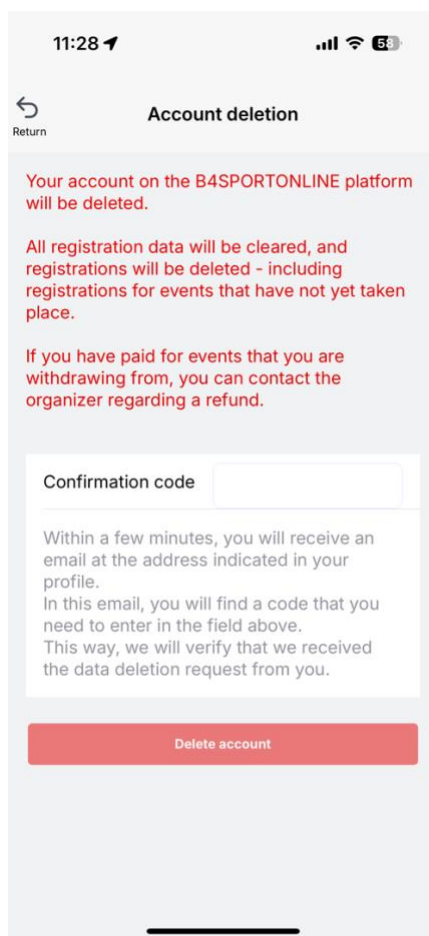
4. After confirming with password, an information screen explains which data will be deleted and the consequences of deletion



5. After clicking “Continue” on the above screen you will then see a confirmation screen warning you that deletion cannot be undone.



6. After confirming, an email with a one-time confirmation code is sent to you, and after providing correct code the process of deletion will start.



7. After confirming all the steps, user will see the status of the deletion process on its profile page
